Residential Statement Information:

- A SERVICE PERIOD TO:** The date which the gas meter was scheduled to be read and upon which the bill will be based.
- B NUMBER OF DAYS:** The number of days since the last scheduled meter reading of the most recent bill.
- C STATEMENT DATE:** The date your bill was processed.
- D THIS MONTH'S CHARGE DUE BEFORE:** The current charges will be past due on the date indicated. It is important that the bill is paid before this date in order to avoid interruption of gas service or late fees.
- E METER NUMBER:** Our identification number for the gas meter.
- F PRES:** (Present) The numbers displayed at the time the meter was read.
- G PREV:** (Previous) The numbers displayed in the previous month at the time the meter was read.
- H CCF:** CCF (100 cubic feet) is the standard unit of gas measurement. The 'Present' number is subtracted from the 'Previous' to calculate the CCF.
- I BTU:** (British Thermal Unit) A unit of heat measurement. This is multiplied by the total CCF.
- J CONVER:** (Conversion Factor) A factor used to accurately calculate therm usage when elevated pressure is required.
- K THERMS USED:** A unit of heat equal to one hundred thousand (100,000) BTU's. This is the total usage applied to calculate the monthly bill.
- L SERVICE:** This indicates the type of customer, i.e. residential, general service, etc.
- M PREVIOUS BALANCE:** This is the balance that appeared on your previous statement.
- N PAYMENT:** This is the amount that Peoples Gas received on your account since the last billing.
- O CUSTOMER CHARGE:** This is a cost that appears on your bill every month whether or not gas service is used. This cost changed mid June 2009.
- P MAIN EXT CHARGE:** A flat monthly fee to recover the cost of extending mains to a particular area when the costs exceeds the maximum allowable construction cost.
- Q DISTRIBUTION:** This is the cost associated with delivering gas to your residence/business.
- R PGA:** (Purchased Gas Adjustment) The cost of gas purchased by Peoples Gas for our customers. Peoples does not make a profit on the cost of gas but simply passes that cost to customers.
- S FRANCHISE FEE:** A fee from a municipality for the right to use public property for the purpose of providing gas service in the area the premise resides. The fee is collected by Peoples Gas and paid to the municipality.

- T LOCAL TAX:** Some municipalities impose a tax on the gas that is used in that area. This tax is collected by Peoples Gas and paid to the municipality.
- U STATE TAX:** A sales tax imposed on commercial accounts by the state of Florida. This tax is collected by Peoples Gas and paid to the State.
- V GROSS RECEIPTS TAX:** A tax from the state of Florida on your purchase of gas. This tax is collected by Peoples Gas and paid to the state.
- W THIS MONTH'S CHARGES:** A sum of all applicable charges for the appropriate month.
- X TOTAL BALANCE DUE:** This will include the current month's charges as well as any previous outstanding charges.
- Y CARBON EMISSION SAVINGS:** This is specifically calculated according to your gas usage.
- * In the event the meter read was estimated, EST appears to the left of the Meter Number.
